# About IUFRO Unit 4.05.00 "Managerial economics and accounting"





Resulting from the merger of the former Working Party

"Managerial economics" with the Research Group "Managerial social and environmental accounting", the Unit concentrates on the economic and accounting aspects of management of different types of forest enterprises, specifically small-scale enterprises. The group deals with the economic analyses of forest enterprises, principles and techniques of accounting relevant to forest enterprises, fundaments of decision-making, and the economic and accounting tools for planning, supervising, measuring, controlling, and evaluating the status and performance of forest enterprises.

The Unit includes two subunits dealing with various aspects of managerial economics and accounting:

4.05.02: Managerial economics
